**LICHFIELD CATHEDRAL TO TAMWORTH CASTLE 2019
VARIOUS ROADS IN THE COUNTY OF STAFFORDSHIRE**

NOTICE IS HEREBY GIVEN that the Staffordshire County Council will make an Order on the 26 March 2019 the effect of which will be to prohibit any vehicle from proceeding in those roads in the District of Lichfield and the Borough of Tamworth that comprise the route of the Lichfield Cathedral to Tamworth Castle 2019 as summarised below. Any vehicle being used in connection with the event will be exempt from the restrictions contained in the Order. All rolling and static closure points will be marshalled to allow access and egress for emergency vehicles and residents when and where safe to do so.

Roads covered by this Order:

Lichfield: Bird Street, Beacon Street, The Close, Dam Street, Conduit Street, Tamworth Street, Greenhill, Rotten Row, Church Street, A5127 Birmingham Road, Sturgeons Hill, Boley Lane, Broad Lane, Cycleway from Boley Cottage Lane to Newlyn Close, Boley Cottage Lane, Ryknild Street, Sandy Lane and Damford Lane

Damford: Damford Lane

Whittington: Damford Lane, Lichfield Road, Marsh Lane and Common Lane

Hopwas: School Lane, A51 Lichfield Road and Coton Lane

Tamworth: Coton Lane, Mariner, Apollo, Moor Street, Prospect Street, Neville Street, Ludgate, Edward Street, Wardle Street, B5493 Lichfield Street.

IT IS ANTICIPATED THAT THE ROADS WILL BE CLOSED FROM 07:30 HOURS. THE ROADS WILL RE-OPEN ONCE THE EVENT HAS CONCLUDED WHICH IS ANTICIPATED TO BE BY 13:00 HOURS.

The Order will come in to operation on the 7 April 2019 and will remain in force until the event has concluded. The event is being organised by Highway Traffic Management Ltd.
